Item 9. Sales of Equity Securities Pursuant to Regulation S.

On January 1, 1997, The Interpublic Group of Companies, Inc. ("Interpublic") issued and sold 20,661 shares of its common stock, par value \$.10 (the "Shares"), to three Canadian individuals (the "Purchasers") in exchange for Canadian \$1,250,000 in value of Class A Preference Shares of Lowe Holdings Ltd., a company incorporated under the Ontario Business Corporations Act. As a result of the transaction and related transactions, Interpublic indirectly acquired a minority interest in Roche Macaulay & Partners Advertising, Inc., a company controlled by the Purchasers. No underwriter or placement agent was used in connection with the sale of the Shares. The transaction was effected in an "offshore transaction" and in accordance with the "offering restrictions" and "no directed selling efforts" requirements of Rule 903(c)(2) of Regulation S under the Securities Act of 1933.
