Item 9. Sales of Equity Securities Pursuant to Regulation S.

On August 30, 1997 The Interpublic Group of Companies, Inc. ("Interpublic") sold 176,819 shares of its common stock, par value \$.10 (the "Shares"), to six individuals (the "Purchasers") in exchange for 5,245,000 Pounds Sterling in value of Ordinary Shares, 1 Pound Sterling par value, of Davies/Baron Limited, a United Kingdom company ("D/B").

As a result of this, Interpublic has acquired 100% of the capital stock of D/B.

No underwriter or placement agent was used in connection with the sale of the Shares.

The transaction was effected in an "offshore transaction" and in accordance with the "offering restrictions" and "no directed selling efforts" requirements of Rule 903(c)(2) of Regulation S under the Securities Act of 1933.
